## Market update on JCDecaux proposal to acquire APN Outdoor Group Limited in Australia

**Paris, June 25<sup>th</sup>, 2018** – JCDecaux SA (Euronext Paris: DEC), notes the announcement from APN Outdoor Group Limited ("APN Outdoor") dated June 25<sup>th</sup>, 2018.

Further to our announcement on June 20<sup>th</sup>, 2018, JCDecaux confirms that it continues to be in discussions with APN Outdoor in relation to its proposal to acquire 100% of APN Outdoor share capital ("Proposal").

Until a transaction is agreed between the parties, there is no certainty that the Proposal will result in any transaction.

JCDecaux will continue to update the market in relation to the Proposal.
